



THE FOLLOWING TERMS AND CONDITIONS APPLY FOR THE THINK.BDPST 2020 CONFERENCE:

1. Customers understand and accept that tickets (also referred to as vouchers) cannot be transferred, exchanged, and refunded. By placing the order, Customers agree that tickets are for personal use and may not be resold or transferred. The resale of tickets is prohibited. The Antall József Knowledge Centre (hereinafter: “**AJKC**”) reserves the right to cancel any tickets that have been resold.
2. No refund on tickets will be made under any circumstances except in case the event is cancelled and *force majeure* (including but not limited to war, revolution, natural disaster, or not foreseeable political events).
3. Customers are asked to present their vouchers in order to receive their badges. Badges can be collected on the spot from 4pm onward on 1 October 2020 and 8am on 2 October 2020.
4. Tickets cannot be collected by third parties without the prior written consent of AJKC.
5. AJKC reserves the right, without refund or compensation, to refuse admission to any person whose conduct is disorderly or unbecoming (including, but not limited to, abusive, threatening, drunken, or other behaviour, or making unauthorised audio, video, or photographic recordings).
6. Customers understand and accept that “think.BDPST” is a trademark of AJKC.
7. Customers understand and accept that no audio or video recording is allowed during the conference unless having the prior written consent of AJKC. Although the event is open for the press, performers and speakers have the right to ask photographers not to take pictures of them. Therefore, guests are kindly asked to refrain from taking pictures.
8. The conference will receive high publicity, and will be recorded in its entirety. By attending the conference, customers acknowledge that their image might be used by AJKC in promotional photographs or their likeness to appear in any live or recorded video display based on AJKC’s legitimate interest.
9. AJKC reserves the right to change the programme.
10. AJKC may postpone, cancel, interrupt, or stop the event in case of adverse weather, dangerous situations, or any other circumstances beyond its reasonable control.
11. Customers understand and accept that AJKC has the right to conduct discreet safety and security checks at the conference, and may, from time to time, carry out security searches in line with the applying legal provisions. Prohibited items, including but not limited to, weapons or dangerous substances are not allowed to be brought to the event, they have to be handed over to the organisers of the conference.
12. Information collected from the registration process in order to execute ticket purchases shall remain confidential and shall be used in accordance with the privacy policy of AJKC, which is part of these conditions.
13. Any complaints regarding the event will be directed to and dealt with by the project manager and the statutory representative of AJKC.



PRIVACY POLICY

The privacy policy of AJKC applies to personal information collected during the registration (name, working place and affiliation, email address, food and dietary restrictions for catering services, password, as well phone number and references where applicable). Information provided by the attendees during registration shall remain confidential, and shall not be sold, traded, or transferred to third parties for commercial purposes. All the personal information collected will be used for creating your badge, processing transactions, or sending newsletters. The e-mail address provided by customers during the registration may be used to send updates and notifications regarding the conference if consumer gives explicit consent for aforementioned data processing. The legal basis of data processing is the informed explicit consent given by the consumer during registration (as per Article 6.1. a) of GDPR). Data necessary for the performance of later transactions are processed based on the performance of a contract by AJKC (as per Article 6.1. b) of GDPR). AJKC processes the personal data only until it is necessary for the purpose stated above.

Please note that, for the purposes of the development and maintenance of the webpages of the event (think.bdpst.org, ylf.think.bdpst.org, startupexpo.think.bdpst.org), the web developer of the think.BDPST webpages, WP Online – Creative Digital, (Seat: 7-8 Ferenciek tere, 1053 Budapest, Hungary), may access, as data processor, personal data provided during the registration process. As data processor, WP Online – Creative Digital keeps all collected data confidential, pursuant to the contract concluded with AJKC. Please also note that, for the purposes of processing and managing your registration, the agency responsible for event management, Ad Valorem (Seat: 48-50 Szent László Way, 1135 Budapest), may, as data processor, also access personal data provided during registration. Ad Valorem is obliged to keep confidential all data as per the data processing contract signed with AJKC.
